

# ... Hife is Good!

Several years ago, I saw a tee shirt that read: "Life's not easy; Life's not fair; Life's not perfect ... Life is GOOD!" For me, these words, both concise and precise, aided in unfolding a fundamental truth that we all must understand if we are ever going to genuinely pursue true happiness. As believers, one of the most essentials aspects in this

pursuit is to still oneself and take the time to reflect more deeply on the dramatic mysteries of our Catholic faith as revealed in the life, passion, death and resurrection of Jesus and how these mysteries give meaning to and impact our lives. Moreover, it is essential to comprehend that life, real life lived well, is not limited to the created things and experiences of this world nor is it devoid of God. Likewise, our faith is not escapism because it neither irradicates nor denies the storms and darkness through which we



may journey, but gives us the strength to continue living through



them and despite them, because our God in the Incarnation of His Son, Jesus, has entered the brokenness of our humanity and is with us in a most intimate way. And finally, as long as we attempt to define by what it "is not," we will experience a profound interior frustration that left unfettered can lead to despair and hopelessness. Thus, the adventure of life is to seek the face of God and the traces of His eternal Presence in the truth, beauty, unity and goodness of His creation so as to discover our true identity and the true meaning of life according to His loving design, whose Author He is. The emblem of our Catholic faith is the crucifix, not simply the cross ... an instrument of torture and death in the ancient Roman empire; but a cross with the crucified body of a person ... a Divine person ... who died for us and our salvation. This "symbol" directs our attention to the reality of the life, passion, and death of Jesus in which we can experience that, in the midst of our hopes and joys, our trials and suffering, God is present and sharing them all with us; and in our Risen Lord's triumph over death, God shows us that His Love triumphs over sin and death and that life in Christ is eternal for those who accept God's invitation.


The intensity of emotion that the crucifix elicits moves us beyond a personal or worldly perspective of life, to a more profound reflection on God's perspective about life, death, and the here-after ... a reality that opens our minds to accept ourselves, not only as individuals born into time and space with bodies that will die ... but individuals called "by name" into existence by the God of Love in the reality of the life of grace which we received in Holy Baptism. This grace-filled reality provides us the potential to break through all "stuff" that binds us to this limited world of fallen creation so that we may touch the face of God in the eternity of His paradise. In this, Jesus broadens our "personal" perspective and opens our hearts to embrace the crucifix, believing that Life is Good, even when it is not fair, easy or perfect;



believing in the More, that is beyond our understanding because it is a gift to each of us from God. This reality ... God's perspective ... is REAL LIFE! Anything else is simply an artifice that will always be wanting, never meeting our expectations and incapable of satisfying the deepest desire of the human heart. This tenet of our Catholic faith is fundamental to our identity as and the mission of a Catholic School in general and Saint Andrew School in particular. The reality that who we are and how we act as Catholic is based on our belief that eternity infuses our history; that grace permeates our nature; that heaven can be realized already, albeit imperfectly, here on earth, because we believe in the mystery of

God, who is Love (1 Jn 4:8) sending His Son, "who was in the beginning with God, who was God" (John 1:1) into the world. His Son, Jesus, "became flesh and made His dwelling among us" (John 1: 14) "not by regarding equality with God something to be grasped. Rather, by emptying Himself, taking the form of a slave, coming in human likeness; and … humbling Himself, becoming obedient to death, even death on a cross." (Philippians 2: 6-8)

More than 1600 years ago, at the end of the first paragraph of his masterful work, *Confessions*, in which St. Augustine "tells of [his] restless youth and of the stormy spiritual voyage that ended some 12 years before the book's writing in the haven of the Roman Catholic Church;" (https://www.britannica.com/topic/Confessions) the middle-aged bishop of Hippo writes: "O God, You have made us for Yourself and our hearts are restless until they rest in You." Similarly, in a reflection on Christmas in his book, The Mystical Way in Everyday Life, Fr. Karl Rahner, S.J., a German theologian of the last century said it thus: "In this way, we are ever confronted with the mystery that "is," that is eternal; in other words: that is origin without beginning, that is ever present and ever retreats untouched. We call this ultimate mystery, God. ... And when we have accepted this thinking,



loving, hoping existence in the depth of our being, despite all the premature, impatient grievances and protests on the surface of our existence, then we have already opened up and given into Him. ... [this is what] is called grace: God is and remains mystery. But God also is the depths where human existence is accepted; a nearness and not only distance, forgiveness and not only judgment. God personally fills the never-ending questions of thought, the vastness of hope, and the eternal demand for love. While remaining silent, God is in that depth of our being which opens up to us only when we humbly allow ourselves to be embraced by mystery without wishing to take charge of it." These

reflections, while erudite and theologically precise, written by two intellectual giants of their times still evince their source in a listening, teachable and prayerful heart. At the same time, despite her simplicity, St. Mother Teresa's words are no less cogent: "We too are called to withdraw at certain intervals into deeper silence and aloneness with God, together as a community as well as personally; to be alone with Him — not with our books, thoughts, and memories but completely stripped of everything — to dwell lovingly in His presence, silent, empty, expectant, and motionless. We cannot find God in noise or agitation. ... We need to find God, and He cannot be found in noise and restlessness. God is the friend of silence. See how nature - trees, flowers, grass- grows in silence; see the stars, the moon and the sun, how they move in silence ... We need silence to be able to touch souls." (Mother Teresa of Calcutta. "In the Heart of the World: Thoughts, Stories & Prayers," 2010.)

The selfless sacrifice, eternity and silence three counter-cultural realities that define us as Catholics and remain stark and challenging invitations to enter more deeply into the reality of God's loving design reveal the true cost of discipleship and in following in the footsteps of Jesus. Amidst the cultural challenges and the effects of lukewarm faith, the crucifix, the promise of eternal life and a



contemplative silence still remain at the center of our mission. These are not passing fads but means that fortify the person to face the rigors of life with courage and encouragement. We cannot pretend that evil does not exist nor that it does not have long term and devastating effects on the lives of our young people. And while they may be confronted with these challenges, we are committed to love them as our good Lord has commanded us and provide them with the tools that He has given to the Church. This is no small task and it will not be achieved unless we strive to incorporate the ideals of

selfless sacrifice, eternity and silence into our own lives. This is the rallying cry to all in our community: to the alumni/ae, to our benefactors, to the parents, guardians, teachers, administrators, staff, clergy and me, together we are called by Jesus to strive each day to genuinely love each other, not as the world defines it ... as a feeling or emotion or something that can be reduced to human control. Genuine love is not a human reality and can never be cheapened as such, because it is the very nature of God and through our Lord's Incarnation, we have been graced with the capacity to love as God is, not as we define it. This is a transformative love to which we are called and committed to preserve, despite our own limitations and failures, this love is unconditional because it is characterized by Christ on the Cross of Calvary ... it is the love that asks no questions; the love that never falters nor stops trying; the love that changes bread and wine into the Body and Blood of Christ; the love that softens the



hardest of hearts; the love that makes the most excruciating sacrifices meaningful; the love in which each of us is called to share "because God first loved us." (1 John 4: 19) During this Year of Eucharistic Revival, I invite each of you to be intentional about renewing your faith in Jesus and your love for the Holy Eucharist and to take some time in the school of Eucharistic Adoration for fifteen minutes or for an hour or more to learn in the powerful Presence of the Master of our hearts the true meaning of selfless sacrifice, eternity and silence and in so doing discover with greater clarity the truth of who we ourselves are as loved, beloved and chosen by God!

In the world today, there are many quick fixes ... to lose weight, to make millions, to get rid of all sorts of problems. Christianity, however, promises us the Cross of Christ and the Resurrection unto Eternal Life. Whatever situation of life in which we may find ourselves, Jesus doesn't promise to take away our conflict or pain, but assures us that He remains faithfully with us no matter what difficulties life has dealt us, even facing death itself. Our Faith doesn't promise us a perfect, or fair or easy life in this world ... but a life that is very good, because it is eternally lived in the loving Presence of God.

Thank you for your generous and on-going support of our mission in these challenging, inspirational and uncharacteristic times. We renew our commitment to remain faithful to the mission to educate, protect and love the students entrusted to our care. May God bless and keep you all.

Above the schoolyard door to the Fr. McShain building are the words "Fides et Scientia" indicating the sharing of faith and knowledge were the primary goals established by the founders of Saint Andrew School. The mission of Saint Andrew School is to build a culture of Life and a civilization of Love through faith and knowledge. In the main office hangs a plaque proclaiming, "Be it known to all who enter here



that Christ is the reason for this school. He is the unseen but ever-present teacher in its classes. He is the model of its faculty and the inspiration of its students." (Author Unknown)

A requirement for accreditation from the Middle States Association of Colleges and Schools (MSA) is the Profile of the Graduate. The Saint Andrew School Parent-Student Handbook (2023) states:

With the help of Jesus Christ, Saint Andrew School graduates will work to build God's kingdom of love and understand that their behavior, either appropriate or inappropriate, reflects upon themselves, their families, and their school. (pp. 5-6)

### 2023 ST. Katherine Drexel Medal Alumni Recipient: Dr. Helen Goggin McLean'74

### Where did you grow up?

I grew up in Drexel Hill. I bought my parent's house in 1989, located in St. Bernadette Parish, which has been my community since age five.

# What were you involved in as a Bonner & Prendie student?

I received a student council nomination but didn't make it. I was a rather shy introvert in high school. Despite that, I enjoyed my time at school. I didn't participate in sports, which disappointed my mother, who thought I should have tried out for the basketball team. However, I was part of the Booster Club and attended many games. I had great friends and teachers who positively impacted me. Sister Anne



Muriel, my religion teacher, and Sister Catherine Maureen, my French teacher, particularly stand out, as does Mrs. Grogan, who taught typing and shorthand skills I've used throughout my career.

#### Did any other family members attend B & P?

Yes, my uncle Jack Goggin was part of the first graduating class of Bonner, and my aunt Kathleen Goggin Buchanan '63 also attended. My two brothers, Chris Goggin '79 and the late Frank Goggin '78 went to Bonner. My four children, Kristin McLean Beverly '99, Trish McLean Schiller '03, Ryan McLean'10, and Maura McLean Kitzinger '12 also attended Bonner & Prendie, along with my son-in-law, Blake Schiller '03 and several nieces and nephews.

#### Why did you want to be a teacher?

Teaching was always my passion. I remember playing school as a kid and never desired to pursue any other career. My first teaching job was at St. Andrew School. As a product of Catholic education, I felt most comfortable in that environment and never considered going into public education. Although the salary may not be the same, I believe God has provided everything I need.

#### Since graduating, where has life taken you professionally and personally?

After obtaining my Bachelor of Science in Education from West Chester University, I taught grades 5, 6, and 8 at St. Andrew School, primarily focusing on math, science, and religion. After teaching for 28 years, I applied for the principal's position in 2006 at my pastor's prompting. After accepting the job, I pursued a Master's in Educational Leadership at Cabrini University, leading to my Principal Certification in 2009. When my daughter, Maura, was a senior at

Prendie and news of the school closing broke, I felt compelled to advance my education further to be a part of the solution to preserve Catholic education in the Archdiocese. In 2018, I completed my Doctorate in Educational Leadership at Neumann University, with my dissertation focusing on Catholic education. I have dedicated my career to Catholic education and have actively participated in committees and organizations, such as the National Catholic Educational Association's (NCEA) National Standards & Benchmarks of Effective Catholic Schools Advisory (NSBECS) Council (NNAC), The Elementary School Administrators Association (ESAA), and the Delaware County Advisory Council.

In 2018, I was honored to receive the NCEA Lead, Learn Proclaim Award, which led to my recognition as a National Distinguished Principal later that year. Sister Edward Quinn, IHM, Assistant Superintendent for Curriculum, Instruction, and Assessment, nominated me because of the incredible growth of Saint Andrew School during my tenure.

#### What does receiving the St. Katharine Drexel Medal mean to you?

Receiving the St. Katharine Drexel Medal is a tremendous honor. Visiting Katharine Drexel's shrine in Bensalem during my time principal left a profound impact on me, especially when one of my students, Christy Callahan, who was hearing impaired, experienced an improvement in her hearing after praying with the Sisters at the shrine. Christy is now a fifth-grade teacher at St. Dot's. Recognizing the historical significance of Katharine Drexel, I feel privileged to be recognized in Katharine Drexel's name. It has a personal meaning to me on various levels. I often pray to St. Katharine Drexel, seeking guidance on how to impact my students. Her story is beautiful, and being associated with her is truly special.

#### How have you exemplified the characteristics described in the award?

Living up to the characteristics of the St. Katharine Drexel Medal means fulfilling one's calling and being attentive to God's guidance through prayer. Although it may not always be convenient or easy, I have found great reward in dedicating myself to teaching and serving in Catholic schools.

CarPop is an entity designed to respond to specific social, economic, health and educational needs of the people in Peru in conjunction with the Order of Saint Augustine (O.S.A./Friars) and the Sisters of Saint Joseph (SSJ/Sisters). The needs of individuals/groups are identified by the friars and sisters and their colleagues in Peru, who carefully vet each opportunity. Funds are then raised by CarPop and matched to the specific needs. One hundred percent (100%) of the funds raised by CarPop go to meeting the needs of the people of Peru.

Sr. Jean took a leave from her position at Chestnut Hill College to work as a missionary in Yauri, Peru for three years from 2006-2009. Sister then went back every summer for five to seven weeks from 2010-2019. Sr. Jean continues to help the Peruvian people through the many who give her donations for Yauri, and thru John's charity.





# Why School Choice?

### "I want to make sure we give every child of God an opportunity to be successful." Gov. Shapiro

The events outlined below over the past few months reminds one of the famous Emerson quote: "What you <u>do</u> speaks so loud that I cannot hear what you say."



Harrisburg, Pa., June 23, 2023 - Today, Pennsylvania Governor Josh Shapiro proclaimed his support for school choice in an interview on *Fox News*. Appearing on *America's Newsroom* with Dana Perino, Gov. Shapiro backed expanding school choice contending that all children deserve the opportunities that school choice programs – like Lifeline Scholarships – provide. According to Shapiro:

"I believe every child of God deserves a shot here in the Commonwealth of Pennsylvania. And one of the best ways we can guarantee their success is by making sure that every child has a quality education.

I've been very clear that I'm open to [school choice]... We've got to invest more in our children, not less. I want to ensure that we give, as I've said, every child of God an opportunity to be successful. I think education is a key to that."

### Two weeks later, on July 6th, Gov. Shapiro line-item vetoed the Lifeline Scholarship Program.

Harrisburg, Pa., August 3, 2023 – Commonwealth Foundation Senior Vice President Nathan Benefield issued the following statement following Gov. Josh Shapiro's decision to line-item veto the Pennsylvania Award for Student Success (PASS) program – also known as Lifeline Scholarships:

"Governor Shapiro's decision to veto the Lifeline/PASS Scholarships, while not unexpected, is disappointing and unnecessary. The Governor's bungling of this budget leaves tens of thousands of children trapped in Pennsylvania's worst-performing schools, devoid of meaningful opportunities to succeed.

"As Governor, Shapiro must demonstrate leadership and work towards brokering a deal that includes Lifeline Scholarships, delivering for the students of the commonwealth. This is his chance to redeem himself, fulfill his campaign promises, and offer a genuine opportunity to thousands of low-income kids who deserve a better future."

The traditional argument against vouchers diverting funds away from public schools is simply untrue under the proposed Lifeline Scholarship Program. Applauds Senate, Urges House to Act on Educational Choice

**Harrisburg, Pa., August 30, 2023** — The Pennsylvania Senate reconvened today and passed legislation necessary to complete parts of the long-overdue state budget. Returning to session three weeks earlier than scheduled, the Senate approved fiscal code legislation that expands educational options for our neediest kids by a bipartisan vote of 28-19.

Notably, the legislation includes Lifeline Scholarships, referred to as the Pennsylvania Award for Student Success (PASS) Program, and the expansion of Pennsylvania's Educational Improvement Tax Credit—both policies Gov. Josh Shapiro campaigned on. Meanwhile, several House Democrat priorities, including the distribution of \$100 million in Level Up funding for school districts, \$50 million for Whole Home Repairs, new student-teacher stipends, and numerous other expenditures, remain pending and will not receive funds unless and until House leaders reconvene and come to an agreement on the overall budget.

"The Senate took a necessary step to move forward on completing a budget. This action shows there is bipartisan support for a deal that delivers for students and taxpayers," said Nathan Benefield, senior vice president at the Commonwealth Foundation. "The onus now lies with House Democrats and Shapiro—the final roadblocks to finalizing the state budget."


The Pennsylvania House of Representatives must agree to fiscal code legislation before the state budget is complete. The House has been in recess since July 11 and isn't scheduled to return until September 26. The Commonwealth Foundation urges the House to get back to work, set aside political gamesmanship, and reconvene to end the budget impasse.

"The intransigence of House Democrats, particularly Leader Matt Bradford, threatens not only scholarships for our most needy students, but funding for all the programs that still need legislation," said Benefield, further emphasizing, "Students are coming back from summer vacation, and it's time for House Democratic leadership to get back to work."

Previously, House Democrat leadership worked to prevent a vote on the fiscal code over objections to the Lifeline Scholarship/PASS Program. However, there is bipartisan support for passing the educational choice initiative. Shapiro also recently reiterated his support for the

proposal, calling it "unfinished business" and noting that the program doesn't take any money from public schools.

<u>July 2023 polling shows</u> 73 percent of voters support scholarship programs like Lifeline Scholarships/PASS. <u>Moreover, 65 percent say Shapiro should honor the deal he made</u> <u>and fund scholarships for children attending the state's worst-performing schools.</u>

A large, bipartisan majority of Pennsylvania voters (65%) believe Pennsylvania Gov. Josh Shapiro should honor the agreement he made with state Senate lawmakers to include Lifeline scholarships in the 2024 state budget, according to a new statewide survey conducted on behalf of the Commonwealth Foundation.


"Pennsylvanians are not only looking for Gov. Shapiro to return to the negotiating table, they are expecting him to take responsibility and step up as a leader to finalize a state budget that includes keeping his promise to help kids trapped in failing and unsafe schools," Commonwealth Foundation Senior Vice President Erik Telford said.

Scholarships for children in the state's worst-performing schools have consistently garnered widespread, bipartisan support. Seventy-three percent of voters in the Commonwealth Foundation survey support "establishing scholarships for low-income students in Pennsylvania's worst performing (bottom 15%) schools that would help pay for tuition to another k-12 school."

"It is not too late for Gov. Shapiro to do the right thing and restore a vital lifeline to parents and children while rebuilding his credibility and proving he is a trustworthy leader," Telford said. "State lawmakers should listen to their voters and finish the job they were elected to do."
